- Within the bpo services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$85,293.2 million in 2021. This was followed by Canada and Mexico, with a value of \$6,292.6 and \$2,493.9 million, respectively.
- The US is expected to lead the bpo services industry in the NAFTA bloc, with a value of \$111,264.3 million in 2026, followed by Canada and Mexico with expected values of \$8,100.2 and \$3,509.2 million, respectively.
