- Within the bpo services industry, China is the leading country among the top 5 emerging nations, with market revenues of \$22,276.6 million in 2021. This was followed by India and South Africa with a value of \$7,266.0 and \$5,118.9 million, respectively.
- China is expected to lead the bpo services industry in the top five emerging nations, with a value of \$29,094.0 million in 2026, followed by India and South Africa with expected values of \$9,733.0 and \$6,526.8 million, respectively.
