- The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The South African footwear market had total revenues of \$1,921.1 million in 2021, representing a compound annual growth rate (CAGR) of 2.1% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the South African footwear market in 2021, sales through this channel generated \$1,526.4 million, equivalent to 79.5% of the market's overall value.
- South Africa is one of the most unequal countries globally in terms of income distribution. Such inequality restricts the demand for high fashion footwear to middle and upper middle-income earners.
