- The Mexican footwear market had total revenues of \$5,422.2 million in 2021, representing a compound annual growth rate (CAGR) of 0.3% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the Mexican footwear market in 2021, sales through this channel generated \$2,479.3 million, equivalent to 45.7% of the market's overall value.
- The country hosts several commercial shows and trade fair such as SAPICA, ANPIC, and other every year to showcase variety of footwear such as flats, sandals, cowboy boots, school footwear, moccasins, and others. Thousands of visitors from different countries visit the show.
