- The US Spirits market had total revenues of \$109,779.7m in 2021, representing a compound annual growth rate (CAGR) of 5.4% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 13.5% between 2016 and 2021, to reach a total of 6,069.8 million liters in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4.6% for the five-year period 2021 2026, which is expected to drive the market to a value of \$137,578.9m by the end of 2026.
