- The Chinese food and grocery retail market had total revenues of \$3,391.7 billion in 2021, representing a compound annual growth rate (CAGR) of 10.7% between 2017 and 2021.

- Convenience Stores (including independents) and gas stations account for the largest proportion of sales in the Chinese food and grocery retail market in 2021; sales through this channel generated \$1,981.2 billion, equivalent to 58.4% of the market's overall value.

- The food segment was the market's most lucrative in 2021, with total revenues of \$2,486 billion, equivalent to 73.3% of the market's overall value.
