- The vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$5,803.3 million, equivalent to 26.1% of the market's overall value.
- Low labor cost combined with highly skilled labor made China one of the top destinations for outsourcing of business process by business leaders to achieve quality work at minimal costs.
