- The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Indian footwear market had total revenues of \$7,383.0 million in 2021, representing a compound annual growth rate (CAGR) of 4.9% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the Indian footwear market in 2021, sales through this channel generated \$4,493.5 million, equivalent to 60.9% of the market's overall value.
- India is home to one of the youngest populations worldwide, which are the key contributors towards the footwear retail market. In 2021, the median age stood at around 28 years in India as compared to 38 and 37 years in the US and China respectively. The continuously rising younger population is leading to declining dependency ratio, thereby leading to increasing income levels per household.
