- The Indian food and grocery retail market had total revenues of \$685.7 billion in 2021, representing a compound annual growth rate (CAGR) of 12.9% between 2017 and 2021.
- Convenience stores (including independents) and gas stations account for the largest proportion of sales in the Indian food and grocery retail market in 2021; sales through this channel generated \$426.8 billion, equivalent to 62.2% of the market's overall value.
- The food segment was the market's most lucrative in 2021, with total revenues of \$573.9 billion, equivalent to 83.7% of the market's overall value.
