The total value of the market represents the demand for the service coming from a particular country.
- The Japanese BPO services market had total revenues of \$16,485.2 million in 2021, representing a compound annual growth rate (CAGR) of 4.2% between 2016 and 2021.
- The vertical-specific BPO segment was the market's most lucrative in 2021, with total revenues of \$5,288.8 million, equivalent to 32.1% of the market's overall value.
- Japan is one of the most advanced countries in terms of technology adoption. Hence, the BPO players are expected to adopt latest technologies such as big data and analytics, cloud computing technology, and others, thereby boosting the market growth.
