Key Highlights

- The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Singaporean footwear market had total revenues of \$1,145.2 million in 2021, representing a negative compound annual rate of change (CARC) of 1.1% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the Singaporean footwear market in 2021, sales through this channel generated \$678.6 million, equivalent to 59.3% of the market's overall value.
- The footwear market is witnessing significant growth across Singapore due to the growing demand for performance/sports footwear across the market. More than 20 million pairs of shoes are sold annually across the country.
