**Summary**

Footwear Retail in Russia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). **Key Highlights**

- The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Russian footwear market had total revenues of \$10,220.4 million in 2021, representing a compound annual growth rate (CAGR) of 0.5% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the Russian footwear market in 2021, sales through this channel generated \$6,664.7 million, equivalent to 65.2% of the market's overall value.
- The positive macroeconomic indicators such as large population base (143.88 million in 2021) is supporting the country's footwear retail market. However, the increased inflation from 4% in 2020 to 8% in 2021 influenced consumer spending, thereby resulting in cutting expenses on footwear category.
