The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Russian BPO services market had total revenues of \$2,475.3 million in 2021, representing a compound annual growth rate (CAGR) of 6.2% between 2016 and 2021.
- The HR outsourcing segment was the market's most lucrative in 2021, with total revenues of \$721.0 million, equivalent to 29.1% of the market's overall value.
- The Russia invasion of Ukraine is expected to affect the country's BPO service market with several players are withdrawing their operations from the country.
