#### Summary

# Key Highlights

- The footwear market consists of the total revenues generated through the sale of all types of men's, women's and children's shoes. It includes all footwear categories for men, women, boys and girls, but excludes sports-specific footwear. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The French footwear market had total revenues of \$9,493.2 million in 2021, representing a negative compound annual rate of change (CARC) of 2.4% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the French footwear market in 2021, sales through this channel generated \$5,560.1 million, equivalent to 58.6% of the market's overall value.
- In 2021, with the revival of the economy the GDP of the country grew by 7% and is expected to further grow by 2.4% and 1.4% in 2022 and 2023 respectively. The final consumption expenditure across the country reached \$2.25 trillion, growing at the rate of 9.2% over 2020. Hence, such growth in consumption expenditure boosted the country's footwear retail market in 2021.
