The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.
- The Spanish BPO services market had total revenues of \$3,811.4 million in 2021, representing a compound annual growth rate (CAGR) of 5.2% between 2016 and 2021.
- The HR outsourcing segment was the market's most lucrative in 2021, with total revenues of \$1,099.2 million, equivalent to 28.8% of the market's overall value.
- The central location of Spain gives it an added advantage and makes it one of the key BPO destinations. The Central European Time (CET) prevalent across the nation keeps it in sync with majority of the European countries and a minor difference of five hours with east coast of the US.
