- The UK Spirits market had total revenues of \$21,003.4m in 2021, representing a compound annual growth rate (CAGR) of -0.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.9% between 2016 and 2021, to reach a total of 559.2 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.4% for the five-year period 2021 2026, which is expected to drive the market to a value of \$24,868.6m by the end of 2026.
