- The food & grocery retail market includes the retail sales of all food products, both packaged and unpackaged, as well as beverages (including retail sales of all alcoholic and non-alcoholic beverages), tobacco, and household products. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Israeli food and grocery retail market had total revenues of \$48.3 billion in 2021, representing a compound annual growth rate (CAGR) of 4.3% between 2017 and 2021.
- Hypermarkets, supermarkets and hard discounters account for the largest proportion of sales in the Israeli food and grocery retail market in 2021; sales through this channel generated \$21.8 billion, equivalent to 45.2% of the market's overall value.
- The food segment was the market's most lucrative in 2021, with total revenues of \$37.2 billion, equivalent to 77.0% of the market's overall value.
