All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Turkish footwear market had total revenues of \$6,826.6 million in 2021, representing a compound annual growth rate (CAGR) of 20.8% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the Turkish footwear market in 2021, sales through this channel generated \$4,377.5 million, equivalent to 64.1% of the market's overall value.
- The footwear market in Turkey witnessed rapid development due to availability of major raw materials, modern manufacturing processes, and skilled workers. The country is also becoming a leading center for leather, which is key raw material for footwear manufacturing.
