- The Turkish Spirits market had total revenues of \$2,421.2m in 2021, representing a compound annual growth rate (CAGR) of 8.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 5.1% between 2016 and 2021, to reach a total of 88 million liters in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 9% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$3,717.1m by the end of 2026.
