All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The global footwear market had total revenues of \$311,822.9 million in 2021, representing a compound annual growth rate (CAGR) of 1.3% between 2016 and 2021.
- Clothing, footwear and accessories specialists account for the largest proportion of sales in the global footwear market in 2021, sales through this channel generated \$163,600.4 million, equivalent to 52.5% of the market's overall value.
- The US accounting for a share of 26.47% is leading the global footwear retail market followed by China holding a share of 20.08%. The growing environmental awareness and the increasing inclination of the consumers towards the sustainable brands is the recent trend observed in the global footwear market.
