The total value of the market represents the demand for the service coming from a particular country.
- The Scandinavian BPO services market had total revenues of \$6,378.9 million in 2021, representing a compound annual growth rate (CAGR) of 6.2% between 2016 and 2021.
- The HR outsourcing segment was the market's most lucrative in 2021, with total revenues of \$1,636.3 million, equivalent to 25.7% of the market's overall value.
- The enterprises across the Nordic region are increasingly adopting IoT solutions which is driving the IoT spending in the market. The need for efficiency, enhancement in business values, and the careful monitoring of business processes is growing significantly across the region.
