In 2022, away-from-home tissue and hygiene registered double-digit current value growth, though constant value sales fell slightly. This was due to soaring inflation caused by an energy crisis, stemming from the war in nearby Ukraine. Away-from home tissue registered higher volume growth than away-from home hygiene, in spite of away-from-home hygiene registering slightly higher value growth. Away-from-tissue benefitted from hospitality returning to full service and office and schools being fully...
