This led to the return of social distancing measures and a semi-lockdown. Schools, offices, and foodservice establishments had to close during the first half of 2022, with consumers limiting their time spent outside of the home to avoid crowds. As a result, demand for away-from-home tissue declined as Hong Kong experienced limited mobility outside of the home until...
