This was driven by a premiumisation trend among more affluent local consumers who value convenience. Moreover, manufacturers had to increase their retail prices due to lingering high raw material costs, related to cellulose, packaging, energy and logistics. This had a subsequent impact on stronger retail value sales to the detriment of retail volumes, especi...
