The US SCADA system market was valued at US\$ 6,170.50 million in 2022 and is projected to reach US\$ 9,050.86 million by 2028; it is estimated to grow at a CAGR of 6.6% during the forecast period. The Japan SCADA System market was valued at US\$ 1,882.24 million in 2022 and is projected to reach US\$ 3,092.34 million by 2028; it is estimated to grow at a CAGR of 8.6% during the forecast period.

It reduces capital and operating costs; creates more streamlined systems; allows for system redundancy; minimizes or eliminates downtime; and increases IT productivity, efficiency, agility, and responsiveness.
