- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The telecommunication services industry within the NAFTA countries had a total market value of \$359.1 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 4.5% over the 2018-22 period.
- Within the telecommunication services industry, the US is the leading country among the NAFTA bloc, with market revenues of \$308.1 billion in 2022. This was followed by Canada and Mexico, with a value of \$31.5 and \$19.5 billion, respectively.
- The US is expected to lead the telecommunication services industry in the NAFTA bloc, with a value of \$342.3 billion in 2027, followed by Canada and Mexico with expected values of \$37.3 and \$26.5 billion, respectively.
