- For all sectors, domestic and international carriage is included. To avoid double-counting in regional and global markets, international freight revenues are assigned to the country of origin.
- All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The global transportation services industry group had total revenues of \$2,755.1 billion in 2021, representing a compound annual growth rate (CAGR) of 4.7% between 2016 and 2021.
