- Among the G8 nations, the US is the leading country in the transportation services industry, with market revenues of \$573,893.6 million in 2021. This was followed by Japan and Germany, with a value of \$115,907.3 and \$103,823.7 million, respectively.
- The US is expected to lead the transportation services industry in the G8 nations with a value of \$766,534.3 million in 2026, followed by Japan and Germany with expected values of \$129,925.3 and \$112,230.3 million, respectively.
