The Mexico was the fastest growing country, with a CAGR of 2.7% over the 2017-21 period.
- Within the waste management industry, the US is the leading country among the NAFTA bloc, with market revenues of \$649,495.3 million in 2021. This was followed by Canada and Mexico, with a value of \$142,876.2 and \$4,659.5 million, respectively.
- The US is expected to lead the waste management industry in the NAFTA bloc, with a value of \$779,543.1 million in 2026, followed by Canada and Mexico with expected values of \$164,980.2 and \$5,504.1 million, respectively.
