- Among the G8 nations, the US is the leading country in the hotels & motels industry, with market revenues of \$172,551.3 million in 2021. This was followed by Italy and the UK, with a value of \$26,843.7 and \$23,459.2 million, respectively.
- The US is expected to lead the hotels & motels industry in the G8 nations with a value of \$300,047.8 million in 2026, followed by Italy and Japan with expected values of \$70,326.9 and \$58,068.4 million, respectively.
