- Within the hotels & motels industry, China is the leading country among the BRIC nations with market revenues of \$92,758.3 million in 2021. This was followed by Russia, Brazil and India with a value of \$13,019.1, \$4,637.3, and \$3,415.2 million, respectively.
- China is expected to lead the hotels & motels industry in the BRIC nations with a value of \$197,084.7 million in 2026, followed by Russia, Brazil, India with expected values of \$22,598.9, \$16,204.3 and \$8,654.0 million, respectively.
