- Within the steel industry, China is the leading country among the BRIC nations with market revenues of \$940,116.1 million in 2021. This was followed by India, Russia and Brazil with a value of \$90,910.6, \$68,485.6, and \$27,871.1 million, respectively.
- China is expected to lead the steel industry in the BRIC nations with a value of \$588,445.5 million in 2026, followed by India, Russia, Brazil with expected values of \$76,491.9, \$49,277.3 and \$21,619.2 million, respectively.
