- Within the consumer electronics retail industry, China is the leading country among the top 5 emerging nations, with market revenues of \$317,108.0 million in 2021. This was followed by India and Mexico with a value of \$73,345.7 and \$30,202.6 million, respectively.
- China is expected to lead the consumer electronics retail industry in the top five emerging nations, with a value of \$478,775.8 million in 2026, followed by India and Brazil with expected values of \$137,592.5 and \$44,187.8 million, respectively.
