The US was the fastest growing country, with a CAGR of 5.1% over the 2017-21 period.
- Within the food & grocery retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,463,354.0 million in 2021. This was followed by Mexico and Canada, with a value of \$183,158.6 and \$150,057.6 million, respectively.
- The US is expected to lead the food & grocery retail industry in the NAFTA bloc, with a value of \$1,724,090.0 million in 2026, followed by Mexico and Canada with expected values of \$247,351.9 and \$182,331.3 million, respectively.
