- The meat market consists of the retail sales of ambient meat, chilled raw packaged meat - processed, chilled raw packaged meat - whole cuts, cooked meats - counter, cooked meats - packaged, fresh meat (counter) and frozen meat. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates.
- The Canadian meat market had total revenues of \$19,994.4m in 2021, representing a compound annual growth rate (CAGR) of 3.9% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.5% between 2016 and 2021, to reach a total of 1,428.4 million kilograms in 2021.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 3.9% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$24,264.4m by the end of 2026.
