- The Canadian seasonings, dressings & sauces market had total revenues of \$3,477.8m in 2021, representing a compound annual growth rate (CAGR) of 3.7% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.4% between 2016 and 2021, to reach a total of 459.1 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.1% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$4,058.3m by the end of 2026.
