- The Mexican hotels & motels industry had total revenues of \$13,148.7 million in 2021, representing a negative compound annual rate of change (CARC) of 8.9% between 2016 and 2021.
- Industry consumption volume increased with a compound annual growth rate (CAGR) of 2.7% between 2016 and 2021, to reach a total of 13,861 establishments in 2021.
- In Mexico, most of the hotels are budget type, accounting for a share of 40.2%, followed by midscale, upscale and luxury segment holding a share of 28.4%, 18.9% and 12.5% respectively.
