- The Mexican pasta & noodles market had total revenues of \$700.1m in 2021, representing a compound annual growth rate (CAGR) of 6.3% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 5.7% between 2016 and 2021, to reach a total of 504.2 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.6% for the five-year period 2021 2026, which is expected to drive the market to a value of \$917.1m by the end of 2026.
