Direct selling re-emerged during the review period, following many years of absence from Uzbekistan. Following poor performances, most companies had exited this channel prior to the review period in 2012, due to tightening restrictions, including leaders such as Faberlic. Faberlic and Oriflame however re-entered direct selling in 2019. The channel benefited from consumers spending more time at home due to the COVID-19 pandemic. Nevertheless, despite most consumers returning to their pre-pandemic...
