Report description:

In 2022 retail in El Salvador rebounded. Stronger macroeconomic indicators and a full return to pre-pandemic lifestyles boosted consumer demand, especially among wealthier shoppers. However, high inflation, widespread informal retailing and a precarious security situation acted as drags on growth. These elements massively impacted consumers' shopping habits and the ability of retailers to expand beyond well-known and safe urban areas. Little improvement is expected over the forecast period.
