- The Brazilian sports equipment retail market had total revenues of \$2,521.5 million in 2021, representing a compound annual growth rate (CAGR) of 3.7% between 2017 and 2021.
- Other specialist retail accounted for the largest proportion of sales in the Brazilian sports equipment retail market in 2021. Sales through this channel generated \$1,313.2 million, equivalent to 52.1% of the market's overall value.
- Sales of indoor exercise equipment and outdoor sporting goods increased during times of lockdown, helping consumers who wanted to stay active during the epidemic reduce losses.
