It also does not include packaging that is used only for transportation purposes such as wooden crates, pallets, steel drums etc.
- The Indian containers & packaging market is expected to generate total revenues of \$41.9billion in 2022, representing a compound annual growth rate (CAGR) of 5.6% between 2017 and 2022.
- Market consumption volume is forecast to increase with a CAGR of 7.7% between 2017 and 2022, to reach a total of 15.7 million Tons in 2022.
- Packaging is one of the fastest-growing markets in India and has been a major market driving technology and innovation in the country.
