The segments include only products that are used explicitly for packaging purposes i.e. the paper segment does not include household and sanitary papers, or printing papers, but does include wrapping papers. It also does not include packaging that is used only for transportation purposes such as wooden crates, pallets, steel drums etc.
- The Spanish containers & packaging market is expected to generate total revenues of \$29.5billion in 2022, representing a compound annual growth rate (CAGR) of -0.3% between 2017 and 2022.
- Market consumption volume is forecast to increase with a CAGR of 1.6% between 2017 and 2022, to reach a total of 11 million Tons in 2022.
- Healthy economic growth during the historical period, followed by growth of consumers' disposable income and strong consumer confidence, maintained high levels of spending which boosted demand in the containers and packaging market.
