The segments include only products that are used explicitly for packaging purposes i.e. the paper segment does not include household and sanitary papers, or printing papers, but does include wrapping papers. It also does not include packaging that is used only for transportation purposes such as wooden crates, pallets, steel drums etc.
- The UK containers & packaging market is expected to generate total revenues of \$45.6billion in 2022, representing a compound annual growth rate (CAGR) of -0.8% between 2017 and 2022.
- Market consumption volume is forecast to increase with a CAGR of 1.1% between 2017 and 2022, to reach a total of 17.1 million Tons in 2022.
- The pandemic has accelerated the transition to online retail, boosting demand for cardboard containers and other forms of paper and paperboard packaging.
