Summary

Tobacco & Tobacco Products in Turkey industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-21, and forecast to 2026). - The tobacco and tobacco products market consists of the retail sale of cigarettes, cigars and cigarillos, smokeless tobacco, and smoking tobacco. The cigarettes segment consists of filter cigarettes and plain cigarettes. The cigars and cigarillos segment comprises large cigars and small cigars. Similarly, the smokeless tobacco segment consists of pipe tobacco and fine cut tobacco (FCT) and the smoking tobacco segment includes snuff/snus and chewing tobacco products. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions used in the creation of this report have been calculated using constant annual average 2021 exchange rates. Market volumes presented in the report (pieces) refer to cigarettes, cigars and cigarillos only.
- The Turkish tobacco & tobacco products market had total revenues of \$6,934.9m in 2021, representing a compound annual growth rate (CAGR) of 2.9% between 2016 and 2021.
- Market consumption volumes declined with a CAGR of -2.7% between 2016 and 2021, to reach a total of 91,889 million pieces in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.4% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$9,003.9m by the end of 2026.
