- The containers and packaging market is a measure of the total volumes and values of production of various types of packaging materials, divided into paper, plastic, metal and glass packaging. The segments include only products that are used explicitly for packaging purposes i.e. the paper segment does not include household and sanitary papers, or printing papers, but does include wrapping papers. It also does not include packaging that is used only for transportation purposes such as wooden crates, pallets, steel drums etc.
- The Asia-Pacific containers & packaging market is expected to generate total revenues of \$368.1billion in 2022, representing a compound annual growth rate (CAGR) of 2.2% between 2017 and 2022.
- Market consumption volume is forecast to increase with a CAGR of 4.2% between 2017 and 2022, to reach a total of 137.7 million Tons in 2022.
- China is the biggest market within the Asia-Pacific region, accounting for 44.8% of the market share in 2022. Followed by India and Japan with 11.4 and 11.2% shares.
