The oils segment consists of cooking sprays, corn oil, olive oil, sunflower oil, vegetable oil, and other edible oils. The solid fats segment consists of compound cooking fats (CCF), ghee, lard, shortening, and other solid fats. The market is valued according to the retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2021 exchange rates.
- The Scandinavian oils & fats market had total revenues of \$1,758.9m in 2021, representing a compound annual growth rate (CAGR) of 4.2% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 3.1% between 2016 and 2021, to reach a total of 314.2 million kilograms in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.1% for the five-year period 2021 2026, which is expected to drive the market to a value of \$1,859.8m by the end of 2026.
