- The Brazilian Oral Hygiene market had total revenues of \$2,724.5m in 2021, representing a compound annual growth rate (CAGR) of 6.7% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.5% between 2016 and 2021, to reach a total of 1,610.1 million units in 2021.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 5.2% for the five-year period 2021 - 2026, which is expected to drive the market to a value of \$3,512.7m by the end of 2026.
