Summary

- The cereal crops sector consists of the production of maize, wheat, rice (paddy) & barley. The 'other' segment consists of other cereal crops such as sorghum, oats, millet, triticale, rye, mixed grain, buckwheat, canary seed and fonio. Production volumes are provided in tonnes and values are calculated at producer prices. All market data and forecasts are represented in nominal terms (i.e., without adjustment for inflation) and all currency conversions used in the creation of this report have been calculated using constant 2021 annual average exchange rates.
- The Brazilian cereal crops industry had total revenues of \$25.9 billion in 2021, representing a compound annual growth rate (CAGR) of 11.3% between 2016 and 2021.
- Industry production volume increased with a CAGR of 2.0% between 2016 and 2021, to reach a total of 126.4 million tonnes in 2021.
- The devaluation of the Brazilian currency led to the rise in prices of various cereal crops including rice, soybeans, wheat, and rice. The COVID-19 pandemic has worsened the economic turmoil, thereby further pushing the prices. However, the cereal producers across the country recorded a profitable season owing to the surge in price levels
