- The Brazilian seasonings, dressings & sauces market had total revenues of \$11,906.5m in 2021, representing a compound annual growth rate (CAGR) of 3.7% between 2016 and 2021.
- Market consumption volume increased with a CAGR of 1.1% between 2016 and 2021, to reach a total of 1,043.3 million kilograms in 2021.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.8% for the five-year period 2021 2026, which is expected to drive the market to a value of \$15,783.2m by the end of 2026.
